After waiting out some winter weather, our team and 900-ton all terrain crane partnered with Okland Construction to hoist a 40,000 steeple housing





## CRANE 101 WHAT'S A JIB?

A jib is a boom attachment that gives the crane operator greater reach. Some are fixed jibs and some are luffing jibs, often called “luffers”. A fixed jib extends reach, but cannot be adjusted where a luffing jib extends reach and the operator can raise or lower the jib. They are often used in situations where the operator needs more tip-height or reach.
